Dear Commissioner Welsh:

Application is hereby made on behalf of **SAMSON CONTOUR ENERGY E & P, LLC**, for the calling of a public hearing, after thirty (30) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the following matters in the **Cris I Zone, Reservoir E**, the **Cris I Zone, Reservoir F**, and the **Cris I Zone, Reservoir G**, all in the **Larose Field**, Lafourche Parish, Louisiana, to-wit:

1. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate from the Cris I Zone, Reservoir E, such unit to be designated Cris I RE SUA;
2. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate from the Cris I Zone, Reservoir F, such unit to be designated Cris I RF SUA;

3. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate from the Cris I Zone, Reservoir G, such unit to be designated Cris I RG SUA;
4. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each proposed unit, with each tract sharing in unit production on a surface acreage basis of participation;
5. To provide that any future wells drilled to the Cris I Zone, Reservoir D, the Cris I Zone, Reservoir E, and the Cris I Zone, Reservoir F, within or outside of the proposed units, should be located in accordance with the spacing provisions of Statewide Order No. 29-E;
6. To provide that the Commissioner of Conservation should be authorized to reclassify these reservoirs by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation; and
7. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cris I Zone, in Larose Field, was fully defined in Office of Conservation Order No. 405-R, effective November 6, 2001.

The pre-application conference tentatively scheduled for November 20, 2007 **WILL NOT BE HELD**, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.

Pursuant to the Revised Rules of Procedure, such list of parties is being furnished **ONLY** to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. 
