BEPCO, L.P. ("Applicant") hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston Formation, Reservoir A, in the Caspiana Field, Caddo and DeSoto Parishes, Louisiana:

1. To permit Applicant to designate and utilize its GA Frierson No. 10 Well as an additional alternate unit well for HOSS RA SUB, said well being located as shown on the attached plat, in exception to the spacing provisions of Office of Conservation Order No. 191-B, effective April 15, 1975, and in lieu of the location approved for this well by Office of Conservation Order No. 191-B-91, effective February 1, 2005.
2. To find that designation and use of this additional alternate unit well is necessary to efficiently and economically drain a portion of the Hosston Formation, Reservoir A, underlying HOSS RA SUB, which cannot be efficiently and economically drained by any existing well within such units.
3. To discuss such other matters as may be pertinent to this application.

The Hosston Formation, Reservoir A, in the Caspiana Field, Caddo and DeSoto Parishes, Louisiana, was defined in Office of Conservation Order No. 191-B, effective April 15, 1975.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.
