

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MARCH 27, 2007**, upon the application of **KERR-MCGEE OIL & GAS ONSHORE, LP.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Gray Sand, Reservoir A**, in the South Sarepta Field, Bossier Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize its Whittington Heirs 28 No. 2 Well as an additional alternate unit well for the GRAY RA SUA, said well to be at the location shown on the plat submitted with the application, in compliance with the spacing provisions of Office of Conservation Order No. 167-F, effective November 1, 1963.
2. To find that this well is necessary to efficiently and economically drain a portion of the reservoir covered by the unit which cannot be drained by any existing well within such unit.
3. To permit the operator to produce the unit allowable in accordance with the provisions of Office of Conservation Order No. 167-F-9, effective March 7, 1995 at a rate equal to the combined rate at which the unit well and the alternate unit well or wells, whether one or more, located on such unit are capable of efficiently producing.
4. Except to the extent herein set forth, to continue in full force and effect the provisions of Office of Conservation Order No. 167-F, effective November 1, 1963, as amended and supplemented by the 167-F Series of Office of Conservation Orders, the units created thereby and applicable Statewide Orders.
5. To consider such other matters as may be pertinent.

The Gray Sand, Reservoir A, was defined in the Office of Conservation Order No. 167-F-2, effective November 12, 1974.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
