

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **WEDNESDAY, JANUARY 17, 2007**, upon the application of **EBR LOUISIANA, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Miocene Zone, Reservoir A**, in the East Manchester Field, Calcasieu Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Miocene Zone, Reservoir A.
2. To create a single drilling and production unit for the exploration for and production of gas and condensate from the Miocene Zone, Reservoir A.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
4. To provide that the Commissioner of Conservation may reclassify the reservoir by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Miocene Zone, Reservoir A, is hereby defined as being that gas and condensate bearing interval encountered between the electric log depths of 3,363 feet and 5,010 feet in the Southland Royalty Company-Stafford No. 1 borehole located in Section 2, Township 10 South, Range 7 West, Calcasieu Parish, Louisiana.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
