

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JULY 22, 2008**, upon the application of **BP AMERICA PRODUCTION COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Upper Tuscaloosa Sand, Reservoir A, the 20,350' Tuscaloosa Sand, Reservoir A, the Lower Tuscaloosa Sand, Reservoir A, the 20,800' Tuscaloosa Sand, Reservoir A, the 21,100' Tuscaloosa Sand, Reservoir A, the 21,300' Tuscaloosa Sand, Reservoir A and the 21,900' Tuscaloosa Sand, Reservoir A**, in the Judge Digby Field, Pointe Coupee Parish, Louisiana.

1. To permit the applicant to drill, designate and utilize its W. C. Parlange, Jr., et al No. 14 Well as alternate unit well for the U TUSC RA SUA, 20350 TUSC RA SUA, L TUSC RA SUA, 20800 TUSC RA SUA, 21100 TUSC RA SUA, 21300 TUSC RA SUA and 21900 TUSC RA SUA, all at the location shown on the plats submitted with the application, in accordance with the spacing provisions of the 1046 Series of Office of Conservation Orders (LAC 43:XIX.1901 et seq. Statewide Order No. 29-E).
2. To permit the operator to produce the unit allowable for the above mentioned units from the existing unit and alternate unit wells and proposed alternate unit well, in any combination, at its option.
3. To find that the aforementioned well is necessary to efficiently and economically drain a portion of the reservoirs covered by each of the subject units which cannot be so drained by any existing well within said units.
4. Except to the extent herein designated, to continue in full force and effect the provisions of Order No. 1046, as amended and supplemented by the 1046-A Series of Orders, and the 1046-C, 1046-D, 1046-E and 1046-F Series of Orders and the units created thereby.
5. To consider such other matters as may be pertinent.

The Upper Tuscaloosa Sand, Reservoir A was redefined in Order No. 1046-A-14, effective January 12, 2000. The 20,350' Tuscaloosa Sand, Reservoir A was redefined in Order No. 1046-A-38, effective April 6, 2004. The Lower Tuscaloosa Sand, Reservoir A, was redefined by Order No. 1046-A-31, effective July 23, 2002. The 20,800' Tuscaloosa Sand, Reservoir A was previously defined in Order No. 1046-F, effective July 23,

2002.

The 21,100' Tuscaloosa Sand, Reservoir A was previously defined in Order No. 1046-D, effective June 2,

1998.

The 21,300' Tuscaloosa Sand, Reservoir A was previously defined in Order No. 1046-C, effective March 19,

1997.

The 21,900' Tuscaloosa Sand, Reservoir A was previously defined in Order No. 1046-E, effective October 30,

2001.
