Dear Commissioner Welsh:

Application is hereby made on behalf of **CHESAPEAKE OPERATING, INC.** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the **Haynesville Zone, Reservoir A**, in the **Caspiana Field**, Caddo Parish, Louisiana, for which rules and regulations were established and a single drilling and production unit was created by Office of Conservation Order No. 191-H, effective August 28, 2007, as amended and supplemented by the 191-H Series of Orders, to-wit:

1. To permit the applicant, Chesapeake Operating, Inc., to designate and utilize the Chesapeake Operating, Inc. – Feist 28 No. 1 Well as the substitute unit well for HA RA SUB at the location shown on the plat attached hereto and made a part hereof, which is in exception to the spacing provisions of Office of Conservation Order No. 191-H-1, effective, September 18, 2007;

2. To the extent not inconsistent herewith, to continue in full force and effect all pertinent provisions of the 191-H Series of Orders; and
3. To consider such other matters as may be pertinent to this application as shown by the evidence presented at the public hearing.


The Haynesville Zone, Reservoir A, in the Caspiana Field, Caddo Parish, Louisiana, was previously defined in Office of Conservation Order No. 191-H, effective August 28, 2007.

Finally, there is enclosed our check in the sum of \$755.00 payable to the Office of Conservation, representing the required hearing application fee.


