On behalf of HUNT PETROLEUM CORPORATION, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Wilcox G2 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana:

1. To permit the applicant to designate and utilize the Hunt Petroleum Corporation - LA Cent O & G No. C-18, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 1235-B, effective January 1, 1986, as a substitute unit well for WX G2 RA SU327.
2. To explicitly find that the proposed substitute unit well is necessary to drain a portion of the Wilcox G2 Zone, Reservoir A, in the Olla Field underlying WX G2 RA SU327, which cannot be efficiently and economically drained by any existing well in such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Wilcox G2 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana, was fully defined in Office of Conservation Order No. 1235-B-8, effective October 7, 1987.

A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Rules of Procedure.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.

This application is being filed in duplicate, and a copy hereof is being sent to Mr. Joseph Devall, Monroe District Manager of the Office of Conservation and to each Interested Owner, Represented Party and Interested Party whose name is shown on the attached list.


