Dear Sir:

Application is hereby made on behalf of Hilcorp Energy Company to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 6-6B Lower Zone, Reservoir A, in the West Bay Field, Plaquemines Parish, Louisiana.

1. To dissolve the 6-6A RD SUA, as established by Office of Conservation Order No. 396-KKK, effective January 29, 2002 and to dissolve the 6BL RC SUA, as established by Office of Conservation Order No. 396-U-1, effective January 8, 2002, both in the West Bay Field, and simultaneously therewith, to create a single drilling and production unit for the exploration for and production of oil and gas from the 6-6B Lower Zone, Reservoir A, in the West Bay Field, Plaquemines Parish, Louisiana.

2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.

3. To designate a unit operator and a unit well for the unit so created, as may be appropriate.

4. To provide that the 6-6B Lower Zone, Reservoir A, should be exempt from the spacing provisions of Statewide Order No. 29-E.

5. To provide that the Commissioner may reclassify the 6-6B Lower Zone, Reservoir A, by supplemental order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner.

6. To discuss any other matters that may be pertinent to this application.

The 6-6B Lower Zone, Reservoir A, in the West Bay Field, Plaquemines Parish, Louisiana, is hereby defined as being that oil and gas bearing zone encountered between the depths of 8,383' and 8,631' electrical log measured depths (7643' to 7871' true vertical depths) less and except that interval between 8,480' and 8,500' electrical log measured depths in the in the Hilcorp Energy Company (formerly LLOG Exploration Company) - S.L. 451 No. 7 Well, located in Section 2, Township 23 South, Range 30 East, Plaquemines Parish, Louisiana.

In addition to furnishing the legal notice to all Interested Parties, the applicant will provide for POSTING of the legal notice of the hearing and unit plat in a prominent place in the area of the West Bay Field, Plaquemines Parish, Louisiana, and will cause the legal notice of the hearing to be PUBLISHED in a newspaper of general circulation published in the vicinity of the West Bay Field, Plaquemines Parish, Louisiana, at least fifteen (15) days before the hearing date.

Any pertinent data relating to the subject application can be obtained, **AT THE COST OF THE REQUESTING PARTY**, from Cambe Geological Services, 6300 Westpark, Suite 400, Houston, Texas 77057 (713-659-8363).

In compliance with the Rules of Procedure, a preapplication notice was given, but no request for a conference was received, and therefore, none was held.

There are attached hereto and made a part hereof a plat outlining the proposed unit and a list of the names and addresses of the Interested Owners, Represented Parties, and Interested Parties to whom this application is being sent. Pursuant to the Revised Rules of Procedure, such list of parties and proposed unit plat (being the same plat attached to the June 23, 2008 notice) are being furnished **ONLY** to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, said plat and the list of parties will be provided to any party requesting copies. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$2265.00 payable to the Office of Conservation and representing the required hearing application fee.
