Application is hereby filed on behalf of Tensas Exploration & Production Company, LLC for the calling of a public hearing, after 10 days legal notice, to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the South Thornwell Field, Jefferson Davis Parish, Louisiana.

1. To grant an exception to the spacing provisions of Supplement Order 479-A, effective February 4, 1997, and to permit the applicant to, complete and utilize the Tensas Exploration & Production Company, LLC – Riviana No. 1 well as a substitute unit well for the MMH RA SUA at the location indicated on the attached plat.
2. To find that the proposed substitute unit well is necessary to effectively and efficiently drain a portion of the reservoir covered by the unit which cannot be drained by any existing well within such unit.
3. Except to the extent herein designated, to continue in full force and effect the provisions of the 479-A Series of Office of Conservation Orders and the units created thereby.
4. To consider any other matters which may be pertinent to this application.

The Main Marginulina Howei sand, Reservoir A, in the South Thornwell, Jefferson Davis Parish, Louisiana, was previously defined in Office of Conservation Order No. 479-A.

Attached hereto and made a part hereof is a plat showing the proposed substitute unit well. There is enclosed a list of names and addresses of the Interested Owners, Represented Parties and Interested Parties who are being forwarded these applications and plats. Such list is being forwarded ONLY to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. 


