Bracky Branch Field, Red River Parish, Louisiana

Dear Commissioner Welsh:

Application is hereby made on behalf of **ENCANA OIL & GAS (USA), INC.** for the calling of public hearings, after legal notice, to consider evidence relative to the issuance of orders pertaining to the following matters:

Hosston Formation, Reservoir A

1. To create seven (7) additional drilling and production units for the exploration for and production of gas and condensate from the Hosston Formation, Reservoir A, in the Bracky Branch Field, Red River Parish, Louisiana, said units to be designated HOSS RA SUAA through HOSS RA SUGG, all as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
3. Except to the extent contrary herewith, to extend to the proposed additional units all pertinent provisions of Office of Conservation Order No. 917, effective November 8, 1973, as amended and supplemented by the 917-C Series of Orders and applicable statewide orders.
4. To consider such others matters as may be pertinent.

The Hosston Formation, Reservoir A, in the Bracky Branch Field, Red River Parish, Louisiana, was previously defined in Office of Conservation Order No. 917, effective November 8, 1973.

Jurassic Zone, Reservoirs A and B

1. To create 10 additional drilling and production units for the exploration for and production of gas and condensate from the Jurassic Zone, Reservoirs A and B, in the Bracky Branch Field, Red River Parish, Louisiana, said units to be designated JUR RA SUB through SUF and JUR RB SUM through JUR RB SUQ, all as shown on the plat attached hereto and made a part hereof.

2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units with each tract sharing in unit production on a surface acreage basis of participation.

3. Except to the extent contrary herewith, to extend to the proposed additional units all pertinent provisions of the respective 917-J Series of Office of Conservation Orders and applicable statewide orders.

4. To consider such others matters as may be pertinent.

The Jurassic Zone, Reservoir A, in the Bracky Branch Field, was previously defined in Office of Conservation Order No. 917-J-1, effective August 1, 2006, and is hereby redefined as being that gas and condensate bearing zone encountered between the depths of 9,555 feet and 12,942 feet (electric log measurements) in the EnCana Oil & Gas (USA) Inc. – Martin Timber Company LLC No. 1 Well, located in Section 10, Township 13 North, Range 10 West, Red River Parish, Louisiana.

The Jurassic Zone, Reservoir B, in the Bracky Branch Field, Red River Parish, Louisiana, was previously defined in Office of Conservation Order No. 917-J, effective August 1, 2006, and is hereby redefined as being that gas and condensate bearing zone encountered between the depths of 10,030 feet and 13,400 feet (electrical log measurements) in the EnCana Oil & Gas (USA) Inc. – A. F. Walker No. 1 Well, located in Section 28, Township 13 North, Range 9 West, Red River Parish, Louisiana, in accordance with EnCana's previously-filed application considered at a hearing held on June 17, 2008, under Docket No. 08-825.


