

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, AUGUST 12, 2008**, upon the application of **KCS RESOURCES, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Lower Cotton Valley Formation, Reservoir A**, in the Terryville Field, Lincoln Parish, Louisiana.

1. To authorize KCS Resources, Inc. to drill, complete and utilize one (1) additional alternate unit well for LCV RA SUM at the exceptional locations shown on the plat submitted with the application.
2. To approve an exception to the well location provisions of applicable Office of Conservation Orders for the Lower Cotton Valley Formation, Reservoir A, to the extent necessary, for the proposed alternate unit well as shown on the plat submitted with the application.
3. To determine that there is a need for additional alternate unit well as indicated to efficiently and economically recover hydrocarbons underlying LCV RA SUM that cannot otherwise be recovered.
4. To authorize the unit allowable for this unit to be recovered from the existing wells located on the unit, the proposed well, or any combination thereof, at the discretion of the operator.
5. To consider such other matters as may be pertinent.

The Lower Cotton Valley Formation, Reservoir A, was defined in Order No. 370-B-6, effective on and after February 18, 1982 and has been redefined by various orders of the 370-B Series of Orders.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
