Cotton Valley Formation, Reservoir A, HOLLY
FIELD, DeSoto Parish, Louisiana.

EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Cotton Valley Formation, Reservoir A, in the Holly Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize a horizontal well as an additional alternate unit well for CV RA SUD at the location shown on the attached plat, and to approve an exception to the spacing provisions of Office of Conservation Order No. 88-E, effective August 1, 1975, for all productive portions of the wellbore of such well located at least 330 feet from a unit boundary.

2. To authorize Applicant to drill, designate and utilize a horizontal well as an additional alternate unit well for CV RA SUE at the location shown on the attached plat, and to approve an exception to the spacing provisions of Office of Conservation Order No. 88-E, effective August 1, 1975, for all productive portions of the wellbore of such well located at least 330 feet from a unit boundary.

3. To find that the proposed alternate unit wells are necessary to efficiently and economically drain portions of the Cotton Valley Formation, Reservoir A, underlying CV RA SUD and CV RA SUE which cannot be efficiently and economically drained by any existing well on such units.

4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley Formation, Reservoir A, in the Holly Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 88-E, effective August 1, 1975.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 North Causeway Boulevard, Suite 204, Metairie, Louisiana 70002-7216. Any person wishing to inspect any such data should call Mr. Louis Gilbert at (504) 834-8112 during normal business hours in order to arrange a date and time for such inspection. A copy of any such pertinent data which is not otherwise available from the Office of Conservation can be obtained from Applicant at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.


