EMPRESA ENERGY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston Formation, Reservoir B, and to the Cotton Valley Formation, Reservoir B, in the Woodardville Field, Bienville Parish, Louisiana:

1. To permit Applicant to drill, designate and utilize one (1) additional alternate unit well for HOSS RB SUQ at the location shown on an attached plat.
2. To permit Applicant to drill, designate and utilize a horizontal well as an additional alternate unit well for CV RB SUQ at the location shown on an attached plat.
3. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the units on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such units.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley Formation, Reservoir B, in the Woodardville Field, Bienville and Red River Parishes, Louisiana, was initially defined in Office of Conservation Order No. 990-B, effective September 13, 2005, was redefined as to the unit designated CV RB SUQ by Office of Conservation Order No. 990-B-10, effective January 9, 2007.

The Hosston Formation, Reservoir B, in the Woodardville Field, Bienville and Red River Parishes, Louisiana, was initially defined in Office of Conservation Order No. 990-C, effective February 1, 2006, and was further defined in Order No. 990-C-8, effective January 9, 2007.



A copy of any such pertinent data which is not otherwise available from the records of the Louisiana Office of Conservation can be obtained from Applicant at the expense of the requesting party.

As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Pursuant to the aforesaid Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of this letter, and of each of the attached plats, is being sent to the District Manager of the Shreveport District of the Office of Conservation and to each of the Interested Owners, Represented Parties and Interested Parties shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing and of the enclosed plats at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Woodardville Field, all in accordance with the Revised Rules of Procedure. Furthermore, a copy of the Legal Notice will be mailed to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

A check payable to the Office of Conservation and covering the application fee is enclosed.







PROPOSED ALTERNATE UNIT WELL PLAT


