Dear Sir:

On behalf of HUNT PETROLEUM CORPORATION, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Wilcox H Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana:

1. To permit the applicant to designate and utilize the Hunt Petroleum Corporation - LA Central O & G No. C-130 Well, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 1235-B, effective January 1, 1986, and to designate said well as an additional alternate unit well for WX H RA SU 479.
2. To explicitly find that the proposed alternate unit well is in the interest of conservation and is necessary to drain a portion of the Wilcox H Zone, Reservoir A, in the Olla Field underlying WX H RA SU 479, which cannot be efficiently and economically drained by any existing well in such units.
3. To provide that the unit allowable for such unit may be produced from either the unit well, the alternate unit well, or any combination thereof, at the operator's discretion.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Wilcox H Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana, was fully defined in Office of Conservation Order No. 1235-B, effective January 1, 1986.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of Blanchard, Walker, O'Quin & Roberts, Chase Tower, 400 Texas Street, Suite 1400, Shreveport, Louisiana 71101. 


