Dear Commissioner Welsh:

Application is hereby made on behalf of **ETOCO, L. P.**, for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the Haynesville Formation, Reservoir A in the North Missionary Lake Field, Caddo and Bossier Parishes, Louisiana:

1. To permit the applicant, **ETOCO, L. P.**, to designate and utilize the **ETOCO, L. P. –Clement Heirs 17 No. 1** well as the unit well for the **HAY RA SU1**, shown on the plat attached hereto and made a part hereof, at an exceptional location to the spacing provisions of Office of Conservation Order No. 961-B.
2. To designate **ETOCO, L. P.**, as the operator of the unit.
3. Except to the extent herein designated, to continue in full force and effect the provisions of the 961-B Series of Office of Conservation Orders relating to the Haynesville Formation, Reservoir A, in North Missionary Lake Field, and all applicable Statewide Orders.
4. To consider such other matters as may be pertinent.

The Haynesville Formation, Reservoir A, in North Missionary Lake Field, Caddo and Bossier Parishes, Louisiana, was previously defined by Order No. 961-B, effective December 2, 1981.

Pertinent data, including well logs, may be obtained AT THE COST OF THE REQUESTING PARTY from Frank W. Harrison, Jr. at 200 Audubon Blvd., Building 28, Lafayette, Louisiana 70503.

Under the Revised Rules of Procedure, this application does not require a pre-application conference and, therefore, no conference has been scheduled or requested.

Attached hereto and made a part hereof is a plat outlining the applicant's proposal and a list of the names and addresses of the Interested Owners, Interested Parties, and Represented Parties to whom a copy of this notice is being furnished. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished only to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation. The list of parties will be provided to any party requesting a copy of it. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties, and Represented Parties.

Finally, enclosed is our check on behalf of the applicant in the amount of \$ 755.00 made payable to the Office of Conservation and representing the required hearing application fee.


