On behalf of HUNT PETROLEUM CORPORATION, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Wilcox A Zone, Reservoir B, in the Nebo-Hemphill Field, LaSalle Parish, Louisiana:

1. To permit the applicant to designate and utilize the Hunt Petroleum Corporation - IPB LLS No. 187 Well, as a unit well for WX A RB SU274, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 781-F, effective January 1, 1986.
2. To explicitly find that the proposed unit well is necessary to drain a portion of the Wilcox A Zone, Reservoir B, in the Nebo-Hemphill Field underlying WX A RB SU274, which cannot be efficiently and economically drained by any existing well in such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Wilcox A Zone, Reservoir B, in the Nebo-Hemphill Field, LaSalle Parish, Louisiana, is fully defined in Office of Conservation Order No. 781-F, effective January 1, 1986.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of the undersigned. Any person wishing to inspect such data should call the undersigned at (318) 221-6858 during normal business hours or write the undersigned at the above address, in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained at the expense of the requesting party.




