Dear Sir:

On behalf of QUESTAR EXPLORATION AND PRODUCTION COMPANY, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Cotton Valley Formation, Reservoir A, in the Thorn Lake Field, Red River and DeSoto Parishes, Louisiana:

1. To permit the applicant to drill, designate and utilize ten (10) alternate unit wells for CV RA SUA, eight (8) alternate unit wells for CV RA SUB, seven (7) alternate unit wells for CV RA SUE and CV RA SUJ, six (6) alternate unit wells for CV RA SUF and CV RA SUM, four (4) alternate unit wells for CV RA SUC and CV RA SUL, three (3) alternate unit wells for CV RA SUD, and two (2) alternate unit wells for CV RA SUK, at the locations shown on the plats attached hereto, and to grant such exceptions to the well spacing provisions of Order No. 1145, effective July 31, 1981, as are necessary with respect hereto;
2. To explicitly find that the proposed alternate unit wells are in the interest of conservation and are necessary to drain a portion of the Cotton Valley Formation, Reservoir A, in the Thorn Lake Field underlying the above referenced units, which cannot be efficiently and economically drained by any existing well in such units.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley Formation, Reservoir A, in the Thorn Lake Field, Caddo and Red River Parishes, Louisiana, is fully defined in Order No. 1145, effective July 31, 1981.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of the undersigned. Any person wishing to inspect such data should call the undersigned at (318) 221-6858 during normal business hours or write the undersigned at the above address in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained at the expense of the requesting party.




