Dear Commissioner Welsh:

Application is hereby made on behalf of **SWEPI LP** for the calling of public hearings, after legal notice, to consider evidence relative to the issuance of orders pertaining to the following matters:

1. To establish rules and regulations and to create 25 drilling and production units for the exploration for and production of gas and condensate from the Cotton Valley Formation, Reservoir A, in the Bayou San Miguel Field, Sabine Parish, Louisiana, said units to be designated CV RA SUA through CV RA SUY, all as shown on the plat attached hereto and made a part hereof.
2. To establish rules and regulations and to create 25 drilling and production units for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Bayou San Miguel Field, Sabine Parish, Louisiana, said units to be designated HA RA SUA through HA RA SUY, all as shown on the plat attached hereto and made a part hereof.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
4. To provide that any wells drilled to the Cotton Valley Formation, Reservoir A, in the Bayou San Miguel Field, within or outside the units created herein, should be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
5. To provide that any wells drilled to the Haynesville Zone, Reservoir A, in the Bayou San Miguel Field, within or outside the units created herein, should be located no closer than 330 feet from existing unit lines and no closer than 660 feet from any wells on competitive units.
6. To provide that the Commissioner of Conservation should be authorized to reclassify the Cotton Valley Formation, Reservoir A, and Haynesville Zone, Reservoir A, in the Bayou San Miguel Field, by supplemental order without the necessity of a public hearing if the producing characteristics of

such reservoirs change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.

7. To consider such others matters as may be pertinent.

The Cotton Valley Formation, Reservoir A, in the Bayou San Miguel Field, Sabine Parish, Louisiana, is hereby defined as being the stratigraphic equivalent of that gas and condensate bearing formation encountered between the depths of 10,280 feet and 11,900 feet (electrical log measurements) in the SWEPI LP – Olympia Minerals 26 No. 1 Well, located in Section 26, Township 9 North, Range 12 West, Sabine Parish, Louisiana.

The Haynesville Zone, Reservoir A, in the Bayou San Miguel Field, Sabine Parish, Louisiana, is hereby defined as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 11,900 feet and 13,395 feet (electrical log measurements) in the SWEPI LP – Olympia Minerals 26 No. 1 Well, located in Section 26, Township 9 North, Range 12 West, Sabine Parish, Louisiana.




