On behalf of COMSTOCK OIL & GAS-LOUISIANA, LLC, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Hosston Zone and Cotton Valley, Reservoir A, in the Logansport Field, DeSoto Parish, Louisiana:

1. To permit the Applicant to designate and utilize its Adams No. 1 - Alt. Well as an additional alternate unit well for HOSS SUYY and CV RA SUV, at the location shown on the plats attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 28-S-4, effective July 22, 1981 and Office of Conservation Order No. 28-W, effective April 22, 1980, which is in lieu of the location approved by Order Nos. 28-S-236 and 28-W-24, effective May 6, 2008.
2. To explicitly find that the proposed additional alternate unit wells and unit well are necessary to drain a portion of the Hosston Zone and Cotton Valley, Reservoir A, in the Logansport Field underlying HOSS SUYY and CV RA SUV, which cannot be efficiently and economically drained by any existing well in such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston Zone in the Logansport Field, DeSoto Parish, Louisiana, was redefined in Office of Conservation Order No. 28-S, effective April 21, 1970.

The Cotton Valley Formation, Reservoir A, in the Logansport Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 28-W-1, effective October 15, 1982.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of the undersigned. Any person wishing to inspect such data should call the undersigned at (318) 221-6858 during normal business hours or write the undersigned at the above address, in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained at the expense of the requesting party.




