APPLICATION FOR PUBLIC HEARING

Dear Sir:

Wildhorse Resources LLC hereby makes application for a public hearing to consider evidence relating to the following matters pertaining to the Hosston Formation, Reservoir C, in the Lucky Field, Bienville Parish, Louisiana:

1. To authorize Wildhorse Resources LLC to drill, designate and utilize an alternate unit well for HOSS RC SUB at the exceptional location shown on the plat attached hereto;
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Hosston Formation, Reservoir C, underlying the HOSS RC SUB which cannot be efficiently and economically drained by any other well;
3. To authorize the unit allowable for HOSS RC SUB to be recovered from the any well located on the unit, at the discretion of the operator; and
4. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.




