Application is hereby made on behalf of **SKLAR EXPLORATION COMPANY, LLC** (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston Formation, Reservoir A, West Arcadia Field, Bienville and Claiborne Parishes, Louisiana:

1. To permit the applicant to drill a unit well for the production of gas and condensate for the Hosston Formation, Reservoir A, in the unit HOSS RA SUE, West Arcadia Field, Claiborne Parish, Louisiana, at the location shown on the attached plat and made a part hereof, the location of which is in exception to the spacing provisions of Office of Conservation Order No. 692-E, effective March 28, 2006.
2. To find that a unit well at the location shown on the attached plat will efficiently and effectively drain hydrocarbon from the Hosston Zone, Reservoir A, in the HOSS RA SUE.
3. To keep in full force and effect the 692-E Series of Office of Conservation Orders and other applicable Statewide Orders to the HOSS RA SUE, except as they may be in conflict herewith.
4. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Hosston Formation, Reservoir A, in the West Arcadia Field, West Arcadia Field, Bienville and Claiborne Parishes, Louisiana, was defined in Office of Conservation Order No. 692-E, effective March 28, 2006.




