EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston A Zone, Reservoir A, the Hosston B Zone and to the Hosston C Zone, all in Bryceland Field, Bienville Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize its H Rogers et al 24 No. 1 Well as an additional alternate unit well for HOSS A RA SUJ, HOSS B SUD and for HOSS C SUL, at the location shown on the attached plats.
2. To authorize Applicant to drill, designate and utilize its George Pipes 19 No. 5 Well as an additional alternate unit well for HOSS A RA SUM, HOSS B SUF and for HOSS C SUE, at the location shown on the attached plats.
3. To approve an exception to the spacing provisions of Office of Conservation Order No. 145-B, effective December 9, 1971 (applicable to the Hosston A Zone, Reservoir A, and the Hosston C Zone) and Office of Conservation Order No. 145-A, effective June 1, 1971 (applicable to the Hosston B Zone), for the locations of both of the proposed wells.
4. To find that the proposed wells are necessary to efficiently and economically drain a portion of the hydrocarbons underlying the units on which they are to be drilled which cannot be efficiently and economically drained by any existing well within these units.
5. To permit the Operator to produce the allowables assigned to these units from either the unit well, any alternate unit well, or from any combination of such wells, at the option of the Operator.
6. To discuss such other matters as may be pertinent.

The Hosston A Zone, Reservoir A, in Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 145-B, effective December 9, 1971, and was further defined as to HOSS A RA SUJ by Office of Conservation Order No. 145-B-12, effective December 5, 1990, and by Office of Conservation Order No. 145-B-23, effective March 2, 1999.


The Hosston B and C Zones in Bryceland Field, Bienville Parish, Louisiana, were defined in Office of Conservation Order No. 145-B, effective December 9, 1971.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 N. A copy of any such pertinent data which is not otherwise available from the records of the Louisiana Office of Conservation can be obtained from Applicant at the expense of the requesting party.

Pursuant to the Revised Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of this letter and of each of the attached plats is being sent to the District Manager of the Shreveport District of the Office of Conservation and to each of the Interested Owners, Represented Parties and Interested Parties as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and of the enclosed plats, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Bryceland Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.


