On behalf of QUESTAR EXPLORATION AND PRODUCTION COMPANY, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Upper Haynesville Formation, Reservoir C, in the East Haynesville Field, Claiborne Parish, Louisiana:

1. To permit the applicant to drill, designate and utilize an alternate unit well for U HA RC SUI, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 105-L-3, effective August 26, 1986;
2. To explicitly find that the proposed alternate unit well is in the interest of conservation and is necessary to drain a portion of the Upper Haynesville Formation, Reservoir C, in the East Haynesville Field, underlying U HA RC SUI, which cannot be efficiently and economically drained by any existing well in such unit;
3. To permit the operator of U HA RC SUI to produce the unit allowable for said unit from the unit well, the alternate unit well, or from any combination thereof, at the operator's discretion; and
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Upper Haynesville Formation, Reservoir C, in the East Haynesville Field, Claiborne Parish, Louisiana, was fully defined in Office of Conservation Order No. 105-L-3, effective August 26, 1986, and was reclassified by Office of Conservation Order No. 105-L-5, effective June 2, 1987.

The Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.




