EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston A Zone, the Hosston B Zone, and the Hosston C Zone, all in the Bryceland Field, Bienville Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize an additional alternate unit well for HOSS A SUH, HOSS B SUK, and for HOSS C SUK, at the location shown on the attached plats.
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the hydrocarbons underlying HOSS A SUH, HOSS B SUK and HOSS C SUK which cannot be efficiently and economically drained by any existing well within these units.
3. To permit the operator of HOSS A SUH, HOSS B SUK and HOSS C SUK to produce the allowables assigned to these units from either the unit well, any alternate unit well, or from any combination of such wells, at the option of the operator.
4. To discuss such other matters as may be pertinent.

The Hosston A Zone and Hosston C Zone in Bryceland Field, Bienville Parish, Louisiana, were defined in Office of Conservation Order No. 145-B, effective December 9, 1971. The Hosston B Zone in Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 145-B, effective December 9, 1971; and was redefined as to HOSS B SUK by Office of Conservation Order No. 145-B-10, effective May 30, 1990, and by Office of Conservation Order No. 145-B-25, effective March 2, 1999.



A copy of this letter and of each of the attached plats is being sent to the District Manager of the Shreveport District of the Office of Conservation and to the Interested Owners, Represented Parties and Interested Parties, as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing and the enclosed plats at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Bryceland Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.






