INDIGO MINERALS LLC ("Applicant") hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston Formation, Reservoir A, and to the Cotton Valley Formation, Reservoir A, in the West Simsboro Field, Lincoln Parish, Louisiana:

1. To permit Applicant to drill, designate and utilize an alternate unit well for HOSS RA SUD, and for CV RA SUB, at the location shown on the attached plats, in exception to the spacing provisions of Office of Conservation Order No. 327-B-2, effective August 1, 1980 (applicable to the Hosston Formation, Reservoir A), and of Office of Conservation Order No. 327-D, effective August 1, 1980 (applicable to the Cotton Valley Formation, Reservoir A).
2. To find that the proposed well is necessary to efficiently and economically drain a portion of the Hosston Formation, Reservoir A, underlying HOSS RA SUD, and a portion of the Cotton Valley Formation, Reservoir A, underlying CV RA SUB, which cannot be efficiently and economically drained by any existing well on these units.
3. To permit the operator of HOSS RA SUD and of CV RA SUB to produce the allowables assigned to these units from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the operator.
4. To discuss such other matters as may be pertinent to this application.

The Hosston Formation, Reservoir A, in the West Simsboro Field, Lincoln Parish, Louisiana, was initially defined in Office of Conservation Order No. 327-B-2, effective August 1, 1980, and was redefined in Order No. 327-B-6, effective March 4, 1986.

The Cotton Valley Formation, Reservoir A, in the West Simsboro Field, Lincoln Parish, Louisiana, was defined in Office of Conservation Order No. 327-D, effective August 1, 1980.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and the enclosed plats, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of West Simsboro Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, we enclose a check payable to the Commissioner of Conservation for the application fee.


