CORONADO ENERGY E&P COMPANY, L.L.C. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston Zone in the Logansport Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to designate and utilize its Christian No. 1 Well, located as shown on the attached plat, as an additional alternate unit well for HOSS SUV, in exception to the spacing provisions of Office of Conservation Order No. 28-S-4, effective July 22, 1981, and in lieu of the location approved for this well by Office of Conservation Order No. 28-S-212, effective May 22, 2007.
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Hosston Zone underlying HOSS SUV which cannot be efficiently and economically drained by any existing well on such unit.
3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston Zone in the Logansport Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 28-S, effective April 21, 1970.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 N. Causeway Blvd., Suite 204, Metairie, Louisiana 70002-7216. Any person wishing to inspect any such data should call Mr. Louis Gilbert at (504) 834-8112 during normal business hours in order to arrange a date and time for such inspection. A copy of any such data which is not otherwise available at the Office of Conservation can be obtained from Applicant at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.
