APPLICATION FOR PUBLIC HEARING

Dear Sir:

KCS Resources, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir A, in the Elm Grove Field, Bossier Parish, Louisiana:

1. To authorize KCS Resources, Inc. to drill, designate and utilize an alternate unit well for HA RA SUA at the location shown on the plat attached hereto and made a part hereof;
2. To establish that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir A, underlying HA RA SUA;
3. To authorize the unit allowable for this unit to be recovered from the existing unit well or the proposed alternate unit well, or any combination thereof, at the discretion of the operator; and
4. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone, Reservoir A, in the Elm Grove Field, Bossier Parish, Louisiana, was initially defined in Office of Conservation Order No. 361-L-1, effective August 26, 2008, and redefined INsofar AND ONLY INsofar AS TO HA RA SUA in Office of Conservation Order No. 361-L-1, effective August 26, 2008.


The subject matter of this application does not require the issuance of a pre-application notice.


