Dear Commissioner Welsh,

Application is hereby made on behalf of McCord Production LLC for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the above captioned zone and reservoir, in the Bayou Choctaw Field, Iberville Parish, Louisiana:

NS ZONE, RESERVOIR A

1. To establish rules and regulations governing the exploration or and production of oil and gas from the Nonion Struma Zone, Reservoir A in the Bayou Choctaw Field, Iberville Parish, Louisiana.
2. To create a single drilling and production unit of approximately 460 acres and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created on a surface acre basis of participation.
3. To provide that the Commissioner may reclassify the reservoir by supplemental order without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished to the Commissioner.
4. To consider any other matters which may be pertinent to this application and justified by the evidence presented at the public hearing.

The Nonion Struma Zone, Reservoir A, is hereby defined as being that oil and gas bearing zone encountered between the measured depths of 11,960 feet and 12,830 feet (electric log measurements) (11,839 feet TVD and 12,588 feet TVD) in the Coastal Oil &

Gas – E. B. Schwing No. A-4 well, located in Section 42, Township 8 South, Range 11 East, Iberville Parish, Louisiana.

The pre-application conference tentatively scheduled for Thursday, February 7th, 2008 at 10:30 a.m. **WILL NOT BE HELD**, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.
