Re: APPLICATION FOR PUBLIC HEARING

Hosston B Zone, Reservoir A, and Hosston C Zone, Reservoir  
A, BEAR CREEK FIELD, Bienville Parish, Louisiana.

Dear Sir:

EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston B Zone, Reservoir A, and to the Hosston C Zone, Reservoir A, in the Bear Creek Field, Bienville Parish, Louisiana:

1. To permit Applicant to drill, designate and utilize an additional alternate unit well for HOSS B RA SUC and for HOSS C RA SUI, and an additional alternate unit well for HOSS B RA SUM and for HOSS C RA SUT, at the locations shown on the attached plats, in exception to the spacing provisions of Office of Conservation Order No. 78-Q, effective February 18, 1971 (applicable to the Hosston B Zone, Reservoir A), and of Office of Conservation Order No. 78-Y, effective September 11, 1980 (applicable to the Hosston C Zone, Reservoir A).
2. To find that drilling, designation and use of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Hosston B Zone, Reservoir A, and the Hosston C Zone, Reservoir A, underlying these units which cannot be efficiently and economically drained by any existing well within these units.
3. To permit the Operator of HOSS C RA SUI and of HOSS C RA SUT to produce the allowables assigned to these units from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the Operator.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston B Zone, Reservoir A, in the Bear Creek Field, Bienville Parish, Louisiana, was initially defined in Office of Conservation Order No. 78-Q, effective February 18, 1971, and was further defined in Office of Conservation Order No. 78-Q-8, effective July 6, 1982.

The Hosston C Zone, Reservoir A, in the Bear Creek Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 78-Y, effective September 11, 1980.



As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Pursuant to the aforesaid Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of this letter and of the two (2) attached plats is being sent to the District Manager of the Shreveport District of the Office of Conservation and to each of the Interested Owners, Represented Parties and Interested Parties shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and of the enclosed plats, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Bear Creek Field, all in accordance with the Revised Rules of Procedure. Furthermore, a copy of the Legal Notice will be mailed to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

A check payable to the Office of Conservation and covering the application fee is enclosed.


