Application is hereby made on behalf of **CHESAPEAKE OPERATING, INC.**, for the calling of a public hearing, after thirty (30) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the following matters related to the **Haynesville Zone, Reservoir A**, in the **Bethany-Longstreet Field**, Caddo Parish, Louisiana, to-wit:

1. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, such unit to be designated HA RA SUA;
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit, with each tract sharing in unit production on a surface acreage basis of participation;

3. To authorize Chesapeake Operating, Inc. to drill, designate and utilize the Chesapeake Operating, Inc. – Bray 27 H No. 1 Well as the unit well for the proposed unit;
4. To designate Chesapeake Operating, Inc. as the operator of the proposed unit;
5. To provide that any future well drilled to the Haynesville Zone, Reservoir A, within or outside of the proposed unit, should be located no closer than 330 feet from any unit boundary and no closer than 500 feet to any other well completed in, drilling to, or for which a permit has been granted to drill to said reservoir;
6. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation; and
7. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, in the Bethany-Longstreet Field, is hereby defined as being that gas and condensate bearing zone encountered between the depths of 10,910 feet and 11,487 feet (electrical log measurements) in the Chesapeake Operating, Inc. – SRLT 29 No. 1 Well, located in Section 29, Township 16 North, Range 15 West, Caddo Parish, Louisiana and is hereby further defined as being that gas and condensate bearing zone encountered between the depths of 11,008 feet and 11,585 feet (electrical log measurements) in the Chesapeake Operating, Inc. – Bray 27 No. 1 Well located in Section 27, Township 15 North, Range 16 West, Caddo Parish, Louisiana.

The pre-application conference tentatively scheduled for February 21, 2008, **WILL NOT BE HELD**, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.




