APPLICATION FOR PUBLIC HEARING

Dear Sir:

KCS Resources, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, Lincoln Parish, Louisiana:

1. To authorize KCS Resources, Inc. to complete and utilize two additional alternate unit wells for LCV RA SUNN, one of which is at an exceptional location, as shown on the attached plat;
2. To determine that there is a need for additional alternate unit wells on LCV RA SUNN to efficiently and economically recover hydrocarbons underlying this unit that cannot be recovered from any other well located on the unit;
3. To authorize the unit allowable for LCV RA SUNN to be recovered from the existing wells located on the unit, the proposed alternate unit wells, or any combination thereof, at the discretion of the operator; and
4. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.


The subject matter of this application does not require the issuance of a Pre-Application Notice.


