Dear Sir:

Application is hereby made on behalf of **WINCHESTER PRODUCTION COMPANY**, (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, Kingston Field, DeSoto Parish, Louisiana:

1. To permit the applicant to drill, designate and utilize eleven (11) alternate unit wells, for the production of gas and condensate for the production of gas and condensate from the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, in the units designate HOSS RA SUO and CV RA SUO, seven (7) of which are located in exception to the spacing provisions of Office of Conservation Orders No. 376-B and 376-C, such units and wells shown on the attached plat and being made a part hereof.
2. To find that the proposed alternate unit wells at the locations shown on the attached plat are necessary to assist in draining a portion of the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, in the units designated HOSS RA SUO and CV RA SUO that cannot be drained by any other well located therein.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit wells or from a combination of all wells at its discretion.
4. To permit the unit operator permission to downhole combine the production from the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, in the units designated HOSS RA SUO and CV RA SUO.
5. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Hosston Formation, Reservoir A, in the Kingston Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 376-B, effective May 2, 1978 and the Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 376-C, effective May 2, 1978.

Upon receipt of the Legal Notice, it will be posted in a prominent place in the area of the Kingston Field, will be published in a newspaper with a circulation in the area of the field and will be sent to all parties to whom this letter is being sent.




