

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 22, 2008**, upon the application of **CORONADO ENERGY E&P COMPANY LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Zone and the Cotton Valley Formation, Reservoir A**, in the Logansport Field, DeSoto Parish, Louisiana.

1. To authorize Applicant to drill, designate and utilize two (2) alternate unit wells for HOSS SU54 and for CV RA SUP, five (5) alternate unit wells for HOSS SUGG and for CV RA SUB, five (5) alternate unit wells for HOSS SUY and for CV RA SUG, two (2) alternate unit wells for HOSS SUZ and for CV RA SUF, and one (1) alternate unit well for HOSS SUV, at the locations shown on the plats submitted with the application.
2. To approve exceptions to the spacing provisions of Office of Conservation Order No. 28-W, effective April 22, 1980 and Order No. 28-S-4, effective July 22, 1981, for the location of any of the proposed wells, as shown on the plats submitted with the application, which does not comply with these spacing provisions.
3. To find that each of the proposed wells is necessary to efficiently and economically drain a portion of the Cotton Valley Formation, Reservoir A and the Hosston Zone, underlying the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
4. To permit the operator of CV RA SUB, CV RA SUF, CV RA SUG and CV RA SUP to produce the allowables assigned to these units from either the unit or substitute unit well, from any alternate unit well, or from any combination of such wells, at the option of the operator.
5. To consider such other matters as may be pertinent.

The Hosston Zone was defined in Order No. 28-S, effective April 21, 1970.

The Cotton Valley Formation, Reservoir A was defined in Order No. 28-W-1, effective October 15, 1982.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
