Application is hereby made on behalf of **WINCHESTER PRODUCTION COMPANY**, (Applicant), to the Commissioner of Conservation for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, Kingston Field, DeSoto Parish, Louisiana:

1. To permit the applicant to drill, designate and utilize eleven (11) additional alternate unit wells, for the production of gas and condensate, eight (8) of which are in exception to the spacing provision of the 367-B and 376-C Series of Office of Conservation Orders, for the production of gas and condensate from the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, in the units designate HOSS RA SUX and CV RA SUX, such units and wells shown on the attached plat and being made a part hereof.
2. To find that the proposed alternate units well at the location shown on the attached plat are necessary to assist in draining a portion of the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, in the units designated HOSS RA SUX and CV RA SUX that cannot be drained by any other well located therein.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit wells or from a combination of all wells at its discretion.
4. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Hosston Formation, Reservoir A, in the Kingston Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 376-B, effective May 2, 1978 and the Cotton Valley Formation, Reservoir A, was defined in Office of Conservation Order No. 376-C, effective May 2, 1978.
