Application is hereby made on behalf of **Goodrich Petroleum Company, L.L.C.** for the calling of a public hearing after ten (10) days legal notice to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the HOSS RB SUX and CV RB SUX, in the Woodardville Field, Bienville Parish, Louisiana:

1. To grant permission to applicant to combine downhole production from the HOSS RB SUX with production from the CV RB SUX, in the wellbore of any existing and future wells located on said units. The interests of the working interest owners and royalty owners in the units are identical.

2. To continue in full force and effect the provisions of Office of Conservation Order Nos. 990-C-11, effective April 17, 2007 and 990-B-13, effective April 17, 2007.

3. To consider such other matters as may be pertinent and appropriate as shown by the evidence presented.

The Cotton Valley Formation, Reservoir B, was fully defined in Office of Conservation Order No. 990-B, effective September 13, 2005.

The Hosston Formation, Reservoir B was fully defined in Office of Conservation Order No. 990-C, effective February 1, 2006.






