## **APPLICATION FOR PUBLIC HEARING**

Dear Commissioner Welsh:

Application is hereby made on behalf of Justiss Oil Company, Inc., P.O. Box 2990, Jena, LA 71342, for a public hearing to consider evidence relative to the issuance of an order pertaining to the following matters:

- 1) To approve the drilling and production of the the Justiss Oil Company - LA Central IPNH #9 well and to designate that well as an alternate unit well for the ANN C RA SUC as defined and described by Order No. 1235-C.
- 2) To recognize that the allowable associated with this horizontal well will be based on the maximum efficient rate (MER) of the well pursuant to the language of Order No. 1235-C.
- 3) To determine that the proposed alternate unit well will effectively and efficiently drain a portion of the reservoir which would not otherwise be drained by the existing unit well.
- 4) To consider any and all other matters which the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

Order 1235-C was promulgated by the Office of Conservation on November 28, 2007, effective October 23, 2007 establishing rules and regulations and creating drilling and producing units for the Olla Field of LaSalle Parish, Louisiana for the Annona Chalk, Reservoir A. The order provides for the following spacing provisions: (a) that the penetration point and terminus of any lateral of any such horizontal well should be located no closer than 330 feet to any unit boundary; (b) that the distance from any point along the productive portion of any lateral and those unit boundaries which run generally parallel to the direction in which the laterals are drilled should not be less than 500 feet; and, (c) that there be no well spacing limitations between wells other than that

accomplished by application of the aforesated provisions.

The Annona Chalk, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana, was defined in Order 1235-C as that oil and gas or gas and condensate bearing interval encountered between the depths of 4,464 feet and 4,594 feet (electric log measurements) in the Justiss Oil Company, Inc - LA Central IPNH No. 3 Well located in Section 1, Township 9 North, Range 2 East, LaSalle Parish, Louisiana.

The applicant attaches hereto a plat showing the location for which this special permit is sought. That plat reflects the surface location for the proposed alternate unit well, which is a horizontal well. The proposed Justiss Oil Company - LA Central IPNH #9 well is located 326 feet from the East line of ANN C RA SUC as defined in Order 1235-C (which point on the East line is also the East line of Section 2, Township 9 North, Range 2 East). Despite the surface location of the well, it will not be in violation of the spacing provisions of Order No. 1235-C as reflected above as the penetration point will be further than 330 feet from the unit boundary.

Inasmuch as the matters covered by this application do not require a pre-application notice, no such notice has been given and it is requested that the hearing be held after the necessary ten day delay following legal advertisement.

In accordance with the Rules of Procedure, the applicant has made a diligent effort to obtain the names and addresses of all interested owners and represented parties to whom notice of this application should be sent and a list of such names is attached hereto.

The applicant will also cause a copy of the legal notice to be published in a newspaper of general circulation in LaSalle Parish, Louisiana and shall post a copy of the notice in a prominent place in the LaSalle Parish Courthouse.

A copy of this letter, the attached plat and list of interested owners and represented parties is being sent to the District Manager of the Monroe District Office.

Also enclosed is a check in the amount of \$755.00 in payment of the required filing fees.
