Dear Sir:

EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston Formation, Reservoir A, and to the Cotton Valley Formation, Reservoir A, in the Kingston Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize one (1) additional alternate unit well for HOSS RA SUA and for CV RA SUA; two (2) alternate unit wells for HOSS RA SUI and for CV RA SUI; one (1) additional alternate unit well for HOSS RA SUAA and for CV RA SUZ; and one (1) additional alternate unit well for HOSS RA SUM and for CV RA SUM; at the locations shown on the attached plats.

2. To approve an exception to the spacing provisions of Office of Conservation Order No. 376-B, effective May 2, 1978 (applicable to the Hosston Formation, Reservoir A), and of Office of Conservation Order No. 376-C, effective May 2, 1978 (applicable to the Cotton Valley Formation, Reservoir A), for the location of any of the proposed alternate unit wells which does not comply with these spacing provisions.

3. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Hosston Formation, Reservoir A, and the Cotton Valley Formation, Reservoir A, underlying these units which cannot be efficiently and economically drained by any existing well on the units.

4. To permit the Operator of these units to produce the unit allowables from either the unit well, from the alternate unit well, or from a combination of such wells, at the option of the Operator.

5. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley Formation, Reservoir A, in the Kingston Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 376-C, effective May 2, 1978.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and the enclosed plats, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Kingston Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

A check payable to the Office of Conservation and covering the application fee is enclosed.


