

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JUNE 3, 2008**, upon the application of **NADEL&GUSSMAN-JETTA OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Pettet Formation, Reservoir A**, in the Dixie Field, Caddo Parish, Louisiana.

1. To create two (2) drilling and production units for the exploration of and the production of gas and condensate for the Pettet Formation, Reservoir A.
2. To force pool and integrate all separately owned tracts, mineral leases and other property within the proposed units in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract to share in the unit production on a surface acreage basis of participation.
3. To designate a unit operator and unit well where applicable.
4. To require future wells to be drilled to the Pettet Formation, Reservoir A, to be located at least 330 feet from unit lines and 1,320 feet between wells.
5. To extend all applicable Office of Conservation Statewide Orders to the proposed units except as they may be in conflict herewith.
6. To consider such other matters as may be pertinent.

The Pettet Formation, Reservoir A is to be defined as that gas and condensate bearing interval found between the depths of 5,121' and 5,433' (electric log measurements) in the Nadel & Gussman-Jetta Operating Company-Franks 17 No. 1 Well, located in Section 17, Township 19 North, Range 14 West.
