Application is hereby made on behalf of **FOREST OIL CORPORATION** for the calling of a public hearing, after thirty (30) days legal notice, to consider evidence relative to the issuance of Orders pertaining to the following matters related to the **Siphonina Davisi Zone, Reservoir B**, in the **West White Lake Field**, Vermilion Parish, Louisiana, to-wit:

1. To establish rules and regulations and create a single drilling and production unit for the exploration for and production of gas and condensate, such unit to be designated SD RB SUA;
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit, with each tract sharing in unit production on a surface acreage basis of participation;
3. To provide that any future wells drilled to the Siphonina Davisi Zone, Reservoir B, within or outside of the proposed unit, should be located in accordance with the spacing provisions of Statewide Order 29-E;
4. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir, by supplemental order without

the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation; and

5. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Siphonina Davisi Zone, in the West White Lake Field, Vermilion Parish, Louisiana, was fully defined in Office of Conservation Order No. 75-J, effective April 24, 2007.

The pre-application conference tentatively scheduled for 10:00 a.m., on Thursday, May 1st, 2008, WILL NOT BE HELD, as it was not requested within the delays provided for by the Rules of Procedure; therefore, no opposition to this Application at the hearing is anticipated.

Pertinent data relating to the proposed application can be obtained, AT THE COST OF THE REQUESTING PARTY, by contacting David Comeaux with Leon E. Comeaux & Associates, P.O. Box 53922, Lafayette, LA 70505, (337) 233-9839.

There is attached hereto and made a part hereof a plat outlining the proposed unit and a list of the names and addresses of the interested parties to whom this unitization proposal is being sent. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, enclosed herein is our check in the amount of \$755.00 made payable to the Office of Conservation in payment of the required hearing application fee.


