

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **WEDNESDAY, JUNE 25, 2008**, upon the application of **ENCANA OIL & GAS (USA), INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Hosston Formation, Reservoir A and the Jurassic Zone, Reservoir A**, in the Martin Field, Red River Parish, Louisiana.

1. To create three (3) additional drilling and production units for the exploration for and production of gas and condensate from the Hosston Formation, Reservoir A.
2. To create eighteen (18) additional drilling and production units for the exploration for and production of gas and condensate from the Jurassic Zone, Reservoir A.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
4. Except to the extent contrary herewith, to extend to the proposed additional units all pertinent provisions of Office of Conservation Order No. 1137-C, effective April 30, 1982, as amended and supplemented by the 1137-C Series of Orders and Order No. 1137-E, effective August 1, 2006 as amended and supplemented by the 1137-E Series of Orders and applicable Statewide Orders.
5. To consider such other matters as may be pertinent.

The Hosston Formation, Reservoir A was previously defined in Order No. 1137-C, effective April 30, 1982, and is hereby redefined as being that gas and condensate bearing formation encountered between the depths of 6,780' and 9,760' (electrical log measurements) in the Amerada Hess Corporation-Morgan Gas Company No. 1 Well, located in Section 14, Township 13 North, Range 9 West.

The Jurassic Zone, Reservoir A was previously defined in Order No. 1137-E, effective August 1, 2006.
