Dear Mr. Commissioner:

Application is hereby made on behalf of **Centurion Exploration Company** for the calling of a public hearing, after ten days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters regarding the W Zone, Reservoir A SUA, Chalkley Field, Cameron Parish, Louisiana, for which rules and regulations were established and a drilling and production unit was created by the Office of Conservation Order No. 68-V, effective December 6, 2007, as revised.

1. To permit applicant, Centurion Exploration Company to drill, designate and utilize the Centurion Exploration Company-Pine Pasture, et al No. 2 Well as an alternate unit well for the W RA SUA, such well to be at the location shown on the plat attached hereto and made a part hereof;
2. To make a specific finding that such proposed alternate unit well is necessary to effectively and efficiently drain a portion of the W RA SUA which cannot be efficiently and economically drained by any other well within the unit.
3. To grant a single unit allowable for the W RA SUA and to permit the operator of the unit to produce said unit allowables from the unit well, the proposed alternate unit well, or from any combination at its option;
4. To confirm Centurion Exploration Company as the operator of the W RA SUA.

5. To find that, except to the extent contrary in the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation No. 68-V, as revised, shall remain in full force and effect, and
6. To consider such other matters pertinent to this application as shown by the evidence presented at the hearing held on this matter.


The W Zone, Reservoir A, Chalkley Field, Cameron Parish, Louisiana was previously defined in Office of Conservation Order No. 68-V, effective December 6, 2007, as revised.

Attached hereto and made a part hereof is a plat outlining the W RA SUA, showing the location of the alternate unit well together with a list of the names and addresses of all interested owners, interested parties and represented parties who are known to the applicant after reasonable search. A reasonable effort was made to ascertain the names and addresses of all such parties.

A copy of the list of the names and addresses of the interested owners, interested parties and represented parties is not being mailed to those parties along with this hearing application. 
