Dear Sir:

EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Hosston A Zone, the Hosston B Zone and the Hosston C Zone, all in Bryceland Field, Bienville Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize an additional alternate unit well for HOSS A RA SUL, HOSS B SUA and for HOSS C SUN at the location shown on the attached plats, in exception to the spacing provisions of Office of Conservation Order No. 145-B, effective December 9, 1971.
2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the hydrocarbons underlying the units on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well within such units.
3. To permit the operator of the units on which this well is proposed to be drilled to produce the allowables assigned to such units from either the unit or substitute unit well, from any alternate unit well, or from any combination of such wells, at the option of the operator.
4. To discuss such other matters as may be pertinent.

The Hosston A Zone in Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 145-B, effective December 9, 1971.

The Hosston B Zone in Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 145-A, effective June 1, 1971.

The Hosston C Zone in Bryceland Field, Bienville Parish, Louisiana, was defined in Office of Conservation Order No. 145-B, effective December 9, 1971, and was further defined in Office of Conservation Order No. 145-B-13, effective December 5, 1990.



As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Pursuant to the Revised Rules of Procedure, Applicant has made a reasonable effort to obtain the names and addresses of all Interested Owners, Represented Parties and Interested Parties to whom notice of this application is being sent and has attached hereto a list of the names and addresses of such parties. A copy of each of the three (3) unit plats is enclosed herewith, and a copy of this letter and of the attached plats is being sent to the District Manager of the Shreveport District of the Office of Conservation and to each of the Interested Owners, Represented Parties and Interested Parties as shown on the attached list.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and of the enclosed plats, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Bryceland Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.


Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.


