Dear Sir:

On behalf of ZADECK ENERGY GROUP, INC., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Hosston Sand, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana:

1. To create one (1) additional drilling and production unit (to be designated as HOSS RA SU75) for the exploration for and production of gas and condensate from the Hosston Sand, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana, as shown on the plat attached hereto.
2. To force pool and unitize all separately owned tracts, mineral leases, and other property interests within said unit, with allocation of production from the unit well to the tracts within such unit therefor to be on the basis of surface acreage.
3. To permit the Applicant to designate and utilize its McNeill et al No. 1 Well as the unit well for the proposed HOSS RA SU75, at the location shown on the plat attached hereto.
4. To designate Zadeck Energy Group, Inc. as the operator of the proposed HOSS RA SU75.
5. Except to the extent contrary herewith, to extend the provisions of Office of Conservation Order No. 123-C-1, effective October 1, 1974, to the proposed unit.
6. To redefine the Hosston Sand, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana, INsofar AND ONLY INsofar as to HOSS RA SU75, as being that gas and condensate bearing interval encountered between the depths of 5800 feet and 6204 feet (electrical log measurements) in the John D. Caruthers, Jr. - Robert D. McIntosh No. 1 Well, located in Section 34, Township 19 North, Range 16 West, Caddo Parish, Louisiana.
7. To consider such other matters and issue such orders as may be appropriate and justified by the evidence presented at the hearing.

The Hosston Sand, Reservoir A, in the Longwood Field, Caddo Parish, Louisiana, was defined in Office of Conservation Order No. 123-C-1, effective October 1, 1974, but shall be redefined as set forth above.

A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Rules of Procedure.

By Pre-Application Notice dated April 30, 2008, applicant advised the Commissioner of Conservation, the District Manager and all Interested Owners, Represented Parties and Interested Parties of applicant's intention to apply for the hearing which is the subject of this application. Applicant received no request for a Pre-Application Conference, and accordingly, no conference was held.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.

This application is being filed in duplicate, and a copy hereof is being sent to Mr. James C. Broussard, Shreveport District Manager of the Office of Conservation and to each Interested Owner, Represented Party and Interested Party whose name is shown on the attached list.


