**APPLICATION FOR PUBLIC HEARING**

Dear Sir:

KCS Resources, Inc. hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Lower Cotton Valley Formation, Reservoir A, in the Terryville Field, Lincoln Parish, Louisiana:

1. To authorize KCS Resources, Inc. to drill, complete and utilize one additional alternate unit well for LCV RA SUS at the exceptional location shown on the attached plat;
2. To authorize KCS Resources, Inc. to drill, complete and utilize six additional alternate unit wells for LCV RA SUNN, four of which are exceptional locations as shown on the attached plat;
3. To approve exceptions to the well location provisions of applicable Office of Conservation orders for the Lower Cotton Valley Formation, Reservoir A, to the extent necessary, for the proposed alternate unit wells as shown on the attached plats;
4. To determine that there is a need for additional alternate unit wells as indicated to efficiently and effectively recover hydrocarbons underlying LCV RA SUS and LCV RA SUNN;
5. To authorize the unit allowable for these units to be recovered from the existing wells located on the units, the proposed wells, or any combination thereof, at the discretion of the operator; and
6. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.


The subject matter of this application does not require the issuance of a Pre-Application Notice.





