On behalf of CSC ENERGY CORP., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Smackover A Zone, Reservoir A, in the Lisbon Field, Claiborne Parish, Louisiana:

1. To create one (1) additional drilling and production unit (to be designated as SMK A RA SUL) for the Smackover A Zone, Reservoir A, in the Lisbon Field, Claiborne Parish, Louisiana, as shown on the plat attached hereto.
2. To force pool and unitize all separately owned tracts, mineral leases, and other property interests within said unit, with allocation of production from the tracts within such unit to be on the basis of surface acreage.
3. To designate Petrochem Operating Company as the unit operator and to designate the Petrochem Operating Company - Meadows No. 1 Well, at the location shown on the plat attached hereto, as the unit well for the proposed SMK A RA SUL to be created hereby.
4. To redefine the Smackover A Zone, Reservoir A, in the Lisbon Field, Claiborne Parish, Louisiana, INsofar ONLY AS TO SMK A RA SUL, as that gas and condensate bearing interval encountered between the depths of 10,150 feet and 10,950 feet (electrical log measurements) in the Union Producing Co. - T.D. Meadows A-1 Well, located in Section 18, Township 21 North, Range 4 West, Claiborne Parish, Louisiana;
5. Except to the extent inconsistent herewith, to extend the provisions of Office of Conservation Order No. 9-M-1, effective June 6, 1975, to the proposed SMK A RA SUL.

6. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Smackover A Zone, Reservoir A in the Lisbon Field, Claiborne Parish, Louisiana was defined in Office of Conservation Order No. 9-M, effective May 14, 1958 and redefined in 9-M-1, effective June 6, 1975, but shall be redefined as set forth above.

Pertinent data concerning the intended application will be made available for inspection at the offices of CSC Energy Corp., 416 Travis Street, Suite 1401, Shreveport, Louisiana 71101. Any person wishing to inspect such data should call Mr. Joel Chevalier at (318) 221-5625, during normal business hours or write Mr. Chevalier at the above address, in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained at the expense of the requesting party.

A list of the names and addresses of all Interested Owners, Represented Parties and Interested Parties (as defined in the Rules of Procedure) is attached hereto, and a copy of this notice, with the annexed plat, is being sent to each of such persons. A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Rules of Procedure.

By Pre-Application Notice dated October 10, 2008, applicant advised the Commissioner of Conservation, the District Manager and all Interested Owners, Represented Parties and Interested Parties of applicant's intention to apply for the hearing which is the subject of this application. Applicant received no timely request for a conference, and accordingly, no conference will be held.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.

This application is being filed in duplicate, and a copy hereof is being sent to Mr. James C. Broussard, Shreveport District Manager of the Office of Conservation and to each Interested Owner, Represented Party and Interested Party whose name is shown on the attached list.
