APPLICATION FOR PUBLIC HEARING

Dear Sir:

Petrohawk Operating Company hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana:

1. To create one (1) additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana, to be designated HA RA SU60, as shown outlined on the plat attached hereto and made a part hereof.
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
3. To designate a unit well and unit operator, as appropriate;
4. To redefine the Haynesville Zone, Reservoir A, INsofar AND ONLY INsofar as proposed HA RA SU60 is concerned, as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 9,828 feet and 11,145 feet (electrical log measurements) in the Encore Operating Louisiana, LLC (formerly Greystone Oil & Gas, LLP) - Querbes No. 2 Well, located in Section 29, Township 16 North, Range 16 West, Caddo Parish, Louisiana;
5. To confirm that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed unit, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary or offset well will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;

6. To extend to the proposed units all pertinent provisions of Office of Conservation Order No. 270-MM, effective June 19, 2007, and as amended and supplemented by the 270-MM Series of Orders, except to the extent inconsistent herewith; and
7. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone, Reservoir A, in the Greenwood-Waskom Field, Caddo Parish, Louisiana, was initially defined in Office of Conservation Order No. 270-MM, effective June 19, 2007, and is to be redefined INsofar AND ONLY INsofar as HA RA SU60 is concerned as provided herein.


