Application is hereby made on behalf of **Hilcorp Energy Company** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the DISC BOL 17 RB SUA, located in the North Freshwater Bayou Field, Vermilion Parish, Louisiana, for which rules and regulations were established and a drilling and production unit was created for the exploration for and production of gas and condensate by Office of Conservation Order No. 973-K-1, effective January 5, 1999.

1. To permit the applicant to designate and utilize its Louisiana Furs Inc. No. F-20 Well as an alternate unit well for the DISC BOL 17 RB SUA, said well to be at the location shown on the plat attached hereto.
2. To permit the operator to produce the unit allowable from the existing unit well, the proposed alternate unit well, or both at its option.
3. Except to the extent herein designated, to continue in full force and effect the provisions of Office of Conservation Order No. 973-K-1.
4. To consider such other matters as may be pertinent to this application.

The Disc Bol 17 Sand, in the North Freshwater Bayou Field, Vermilion Parish, Louisiana, was fully defined in Office of Conservation Order No. 973-K-1, effective January 5, 1999.

The designation of the proposed alternate unit well would permit efficient and economic recovery of the hydrocarbons underlying said unit and is needed to satisfy the market demand for gas and condensate from the field.

Any pertinent data relating to the subject application can be obtained, **AT THE COST OF THE REQUESTING PARTY**, from Cambe Geological Services, 6300 Westpark, Suite 400, Houston, Texas 77057 (713-659-8363).

There is attached hereto and made a part hereof a plat showing the applicant's proposal. Pursuant to the Revised Rules of Procedure, a list of names and addresses of the Interested Owners, Interested Parties and Represented Parties to whom this application is being sent is being furnished only to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. However, the list will be provided to any party requesting a copy. A diligent effort was made to ascertain the names and addresses of all Interested Owners, Interested Parties and Represented Parties as required by the Revised Rules of Procedure.

Finally there is enclosed our check on behalf of the applicant, Hilcorp Energy Company, in the sum of \$755.00 payable to the Office of Conservation and representing the required hearing application fee.


