

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, DECEMBER 1, 2009**, upon the application of **PANAMERICAN OPERATING, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Cockfield Zone, Reservoir A**, in the Basile Field, Acadia Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Cockfield Zone, Reservoir A.
2. To create a single drilling and production unit for this zone and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate a unit operator and a unit well for the unit so created, as may be appropriate.
4. To provide that any future wells drilled to the Cockfield Zone, Reservoir A, within or outside of the unit created herein, should be located in accordance with the provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
5. To provide that the Commissioner of Conservation may reclassify the reservoir by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
6. To consider such other matters as may be pertinent.

The Cockfield Zone is hereby defined as that stratigraphic interval encountered between the depths of 9,868' and 11,024' (ELM) in the Sun Oil Company-Sidney M. Pelloquin No. 1 Well (SN 145141), located in Section 26, Township 6 South, Range 2 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
