APPLICATION FOR PUBLIC HEARING

Dear Sir:

Petrohawk Operating Company hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Haynesville Zone, Reservoir A, in the Haughton Field, Bossier Parish, Louisiana:

1. To create one additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Haughton Field, Bossier Parish, Louisiana, to be designated HA RA SUN, as shown outlined on the plat attached hereto and made a part hereof;
2. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
3. To designate a unit well and unit operator, as appropriate;
4. To confirm that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, in or to serve the proposed unit, where the horizontal lateral portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and offset wells in adjacent units will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;
5. To extend to the additional unit, except to the extent inconsistent herewith, the provisions of Office of Conservation Order No. 956-C, effective May 19, 2009 as amended and supplemented by the 956-C Series of Orders, and all applicable Statewide Orders; and

6. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Haynesville Zone in the Haughton Field, Bossier Parish, Louisiana, was defined in Office of Conservation Order No. 956-C, effective May 19, 2009.

A Pre-application Notice letter dated October 2, 2009, was circulated in connection with this matter. There was no request received for a conference; accordingly, no conference will be held.

A copy of this application, with plat attached, is being sent to each such party. Pursuant to Office of Conservation regulations, the list of parties is being furnished only to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation; however, the list of parties will be provided to any person requesting a copy of it. Enclosed with the copy of this application being sent to the Commissioner is a check for the application fee.


