Application is hereby made on behalf of Perkins Oil Properties for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an Order pertaining to the following matters relating to change of operator regarding certain wells in the Converse Field, Sabine Parish, Louisiana:

1. To remove the existing operator, High Hope Oil & Gas, Inc. and to designate the applicant as operator of the following wells: the Fred VUB ExxonMobil No. 1 Well (Serial No. 234497), and the Fred VUA Jagneaux No. 1 Well (Serial No. 232591), both in Converse Field, Sabine Parish Louisiana.
2. To consider such other matters as may be pertinent.

The applicant, Perkins Oil Properties, filed Form MD-10-R-AO to amend operator designation of the aforementioned wells; however, a letter of objection was filed with the Office of Conservation by the existing operator, High Hope Oil & Gas, Inc., opposing the change of operator. Therefore, Perkins Oil Properties hereby requests that this matter be considered by the Commissioner of Conservation at a hearing called for that purpose.
